

- d. This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- e. The Memorandum of Understanding shall be reviewed at the end of every academic year.
- f. Either parties can terminate the Memorandum of Understanding after giving one month's notice to the other party subject to fulfillment of commitments already agreed upon.
- g. The details for the efficacious implementation of this Memorandum of Understanding shall be jointly worked out on mutually acceptable terms within the parameters of the policies, rules and regulations of both the institutions.
- h. The parties to this memorandum may, by mutual consent, adds, modify, amend, delete, review or revise any term (s) and condition (s) of this agreement.
- i. The parties to this Memorandum of Understanding undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the other institution, which is so classified in advance. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

- j. This Memorandum of Understanding shall require the rectification of the competent academic or executive body of both the institution.
- k. Any dispute arising out of this Memorandum of Understanding will be settled by mutual negotiations between the two parties.
- 1. There will be no financial liabilities and obligations for both the organizations.
- m. Both the organizations will appoint a person to serve as the official contact and co-ordinate the activities of each organization in carrying out this Memorandum of Understanding.
- Duration of MOU: the MOU unless extended by mutual written consent of the institutions, shall expire in five years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another two years by mutual consent.
