The institution runs Late Sulbhatai Jagtap Madhyamik Vidhyalaya located in Nimgavhan, Tah.- Chandur Rly, Late Atul Jagtap Madhyamik Vidhyalya, Rajarshee Shahu Science and Atul Jagtap Arts Junior College, and Rajarshee Shahu Science College located in Chandur Railway, Dist. Amravati, Maharashtra.

Rajarshee Shahu Science College was established in the year 2008 under able leadership of Late Hon'ble Prof Anna Saheb Jagtap, Prof. Dr. Virendra Jagtap and Prof. Uttaratai Jagtap. The college is 100% grant-in-aid Science College offering undergraduate program (B.Sc.) and is permanently affiliated to the Sant Gadge Baba Amravati University, Amravati.

The college imparts education with a mission responding to the demand of time and needs of the society taking into consideration the socio-economic, political and administrative challenges. Since its inception, the college has been rendering great service to the socially backward and marginalized student in higher education.

Curricular Aspects

Our college is affiliated to Sant Gadge Baba Amravati University Amravati and follows the curriculum and academic calendar stipulated by the University. Institute has devised its own mechanisms for the effective implementation and delivery of the curriculum with strict adherence to the University Academic Calendar. At the beginning of the Academic session college prepare the Academic Calendar and time table accordance with the University Academic Calendar. Teachers plan the curriculum prescribed by the university at micro level in each semester. For Robust Curriculum Delivery teachers use ICT tools, assignments, Projects, Presentation, need based survey Programs, Group Discussion, field visit and educational excursion etc. IQAC ensures effective curriculum delivery through a designed mechanism. To encourage participative and collaborative learning, opportunities were provided to the student through clubs and society where students learn life skills, develop competence and positive behaviors.

Students are encouraged to participate in workshops, seminars and other various academic and research events organized in and outside the campus that help them expand their intellectual horizon and develop the confidence. Numbers of program are organized to gain a better understanding of the issues relevant to professional ethics, gender, human values, environment and sustainability and develop skills to address them in their personal and professional lives.

The college has a structured system for collecting feedback from all stakeholders for further analysis and action. The analyzed feedback and action taken reports are displayed on the institutional website.

The important documents like Time table, Teachers Academic Diary, Micro teaching plan, Result Analysis and Mentor-Mentee records and students' feedback on curriculum are typically maintained for curriculum delivery. By maintaining these documents, institution ensures that curriculum delivery is organized, efficient and effective. It also helps teachers to track their progress and make improvements to their teaching practices.

Teaching-learning and Evaluation

The college offers only B.Sc. programme with clearly stated and well defined Programme Outcomes (POs) and Course Outcomes (Cos). COs and POs are displayed on the website. The maximum number of students that our institution can admit to a B.Sc. program per year is 120 and 10% more of intake capacity are permissible after the initial capacity has been reached.

Admission mechanisms are designed to ensure the fairness and transparency in the admission process. The institution follows the open admission mechanism, where any student who meets the minimum requirement is admitted to the program. Also follows the reservation policies that enshrined in the state government GR. The COVID-19 pandemic has had a significant impact on the admissions that reflects in the admission strength of last two years. The enrolment percentage of the students for the assessment period is 86.38 and percentage of seats filled against seats reserved for various categories is 75.58. In the last session of the assessment period i.e.2021-22, the ratio of student-full time teacher is 279:16 (17:01) and the percentage of full- time teachers with *NET/SET/ Ph.D. is* 100%.

To enhance learning experiences of the students, teachers use other student centric methods of teaching like seminars, quiz, group discussion, poster presentation, industrial visit, educational tour, arrange guest lecture, Hands on training, workshops, project work, computer-assisted, experiment, software based, ICT based etc. During COVID-19 pandemic situation, the college succeeded in engaging the students by leveraging technology and creativity to provide high-quality education in an online mode of learning.

College has Continuous Evaluation Committee which monitors and conducts college examinations. The students are made aware about the internal and external assessment mechanism, mark system and grievances and redressal system to maintain the transparency in the assessment process. The institute has a system in place for measuring the level of attainment of course outcome and program outcome. The pass percentage of students during last five year is 78.66. Institution conducts online students satisfaction survey on teaching and learning that helps to make improvement in the areas that need attention.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The National Education Policy (NEP) objective is to create in learners a deep sense of pride in being Indian, not just in idea but also in spirit, intellect, and acts, as well as to help them acquire the information, skills, attitudes, and dispositions that go along with that pride. The institution believes that the commitment to human rights, sustainable development and living, and global well-being, thereby reflecting a truly global citizen. The Institute is affiliated to Sant Gadge Baba Amravati University, Amravati where in Academic programmes are redesigned to include Multidisciplinary

/Interdisciplinary courses as electives and institute will be start offering these electives to students.

Institution will be planning to conduct survey in local area to explore the likening and demand of regional students to give rise to multidisciplinary and interdisciplinary curriculum. Thus, institution framed a committee that is responsible to implement the NEPbased curriculum in line with the national vision across the entire programme it offers. The institution offers PhD programmes with adequate research facilities in major science subjects. The faculty and research students will be encouraged undertaking interdisciplinary and multidisciplinary research projects. The college runs the activities that are interdisciplinary and multidisciplinary, such as biodiversity conservation, Solar Energy, Mushroom Culture etc. All these activities have a blend of two or more subjects, Chemistry, Physics, Zoology, Computer Science, Mathematics and Electronics. Additionally, our students participate in community outreach initiatives such as organizing health awareness programs, on various diseases like AIDS, Cancer, personal hygiene etc. were conducted in neighborhood villages. It can be said that the Institute is proactively working towards implementation of the suggestions given in the NEP Guidelines.

2. Academic bank of credits (ABC):

A crucial part of the NEP-2020 that academic institutions must adopt is academic bank of credits. Being affiliated to Sant Gadge Baba Amravati University, Amravati, Our College is bound to follow the courses, syllabi and other rules & regulations of the affiliating University. Due to the implementation of National Education Policy, affiliated universities have already taken the initiative to introduce competence-based systems at the undergraduate level. A committee will be formed in the college to introduce the students the Academic Bank of Credit. We are in process to implement online courses through National schemes like SWAYAM, NPTEL, Coursera, etc for our students and considering for credits earned against elective courses.

3. Skill development:

For the UG programme, the affiliating university took the initiative to design a learning outcome-based curriculum structure that is in line with NEP's goals for promoting high-quality education. The mission of the college is to provide skills-based education to the students. Hence the college takes efforts to inculcate positivity among the learners. The college has started arranging skill development programs for the

students of different faculties as per their need. Workshops and seminars were held to support the program's promotion of vocational education. Workshop on soft skill for professional development, workshop on skill development and hand holding through fashion designing, three days' workshop was organized on Nursery techniques and Management, Workshop on Laser and its Application. The students from B.Sc. III of stream did registration to "LifeSkill Training Programme 21-22. This initiative is supported by Barclays. Under this program, students will be trained by Corporate Trainers to enhance their Life skills which would help them significantly to increase their chance of succeeding in a job interview. Our Institute organized activities like Human Rights, Voter Awareness, Environment Problems, Gender Sensitization, Yoga and Meditation to promote value-based education and optimism among the students. An annual magazine 'SANKALP' provides a platform for students to express themselves and share their thoughts, creativity, opinions, and perspectives. This can help them to improve critical thinking skills, writing skills and build confidence in their abilities. The sports department play an important role in supporting students in their career aspirations by providing opportunities, resources, and support related to sports and related fields. Students are trained to participate in various sports competition at University, State and National Level. Also, the sports department play an important role in developing leadership skill. Peer teaching helps students to develop a range of skills that are valuable for academic and personal success. Peer teaching help students develop their teamwork, problem-solving, conflict resolution skills, verbal and nonverbal communication skills, develop selfawareness and become more effective learners. NSD celebration and conduction of an activity like "SHANIWARI VIDNYANWARI" help students become more proficient in the scientific method and gain a better understanding of scientific concepts.

4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):

The National Education Policy 2020 envisions an educational system fashioned on the lines of India's profuse linguistic, cultural and artistic heritage. The promotion of Indian arts and culture is seen very important which would not only develop a strong sense of identity and aesthetic outlook but also

enhances creative and cognitive skills among the students. The Cultural Committee of our College, strives to celebrate the cultural diversity in the college by organizing Various competitions, events, activities, programs and Days like, annual function Tarangani, Women's Day, Garba Event etc. College organized essay competition for students in Marathi language. Every year college magazine 'Sankalp' is released. Students express their local life experiences and aspirations through the college magazine through writing created by them. India is having very big and significant history of ancient literature. Mahanubhav Panth and its scripts created by Lord Chakradhar Swami is one of these. To make students and citizens familiar with this Pantha and its literature which is having the history of more than 700 year ago, the college has organized one day workshop on 'Prachin Sanhita Wachan (Ancient Code Reading) and Information & Photo Exhibition in collaboration with Sant Gadge Baba Amravati University's Mahanubhav Adhyasana. In order to enhance local knowledge and culture, several components of the curricula for subjects like English, Marathi, and Botany are based on traditional and ancient aspects.

5. Focus on Outcome based education (OBE):

NEP's new model, called STEAM, focuses on experiential, application-based learning and research-based internships. Faculty members are encouraged to conduct high-quality results-oriented research to generate intellectual property (patents and copyrights). Students are encouraged to explore the practical aspects of learning and foster student innovation by participating in various science fairs, innovations, competitions, and more. Program Outcomes (PO), Program Specific Outcomes (PSO), and Course Outcomes (CO) are designed by the university and adhere to NEP guidelines. The institute has been taking efforts for program outcome, program specific outcome and course outcome.

6. Distance education/online education:

College used earlier well established online platform, Google Workspace (Google meet, Google form, Google Chat, G-mail, Google Classroom, Google Doc, Jam board etc.) to run all academic activities including teaching-learning, evaluation and also many co-curricular, extra-curricular and extension activities in the pandemic situation for the entire academic year. Conference (1) workshops (5) webinars (3) and meetings of various committees

(24) were also conducted on the same platform. All these activities were successfully run and the loss caused to the education process by the pandemic is mostly compensated by this online platform. All the students, teachers and other staff members have their activated institutional email addresses. Google form is used for Evaluation of Internal assessment as well as collecting feedback and issuing of E -certificate. Faculties participated in Faculty development programme, Induction programme, E-conferences, conducted by SWAYAM/MOOC/NPTL.

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

Our college follows the curriculum of the affiliating university. The college ensures effective curriculum delivery and its completion through systematic and strategic transparent mechanism.

Planning:

- At the beginning of the every academic session concern committee with suggestions of all HOD's, prepares college academic calendar in harmonious with the university academic calendar.
- Approved academic calendar is communicated to all teachers and same is uploaded on the college website for student's information.
- Time-Table committee prepares a teaching time-table as per the teaching workload provided by the heads of the departments and communicates it to all HODS for further departmental planning.
- Heads of the departments convene a meeting with the departmental faculty members for preparation of departmental time-table and syllabus distribution. HOD allocates the units to the faculty members based on their choice of expertise and experience.
- For the students' convenience, all departments display time-table on the departmental notice boards.
- All teachers write well-structured course plan on the academic diary and submit it to the IQAC for its approval before implementation.
- At the end of every academic session Principal sends a notice to all Heads of the departments to prepare and submit budget requirement for reference books, laboratory chemicals and equipments and other materials necessary for curriculum implementation for next academic session. Budgets are further discussed in CDC for its approval.

Curriculum Delivery and Review:

- A comprehensive planed course which includes lectures, tutorials and practicals is delivered by every teacher through various classroom activities and activities outside the four walls of the classroom such as bridge courses, informing about PO & CO, chalk and talk, ICT tools, Peer teaching, guest lectures, PPTs, projects, seminars, field visits, industrial and institutional visits, excursions, laboratory experiments etc.
- Students are identified as slow learners and advanced learners on the basis of their previous score
 and the tests conducted by the subject teachers. The teachers carry out necessary activities to cater
 to the different needs of these learners. Remedial coaching is given to slow learners for their
 academicals enhancement while advanced learners are motivated to participate in collegiate and
 intercollegiate competitions like seminar competition, Avishkar etc. Also students are motivated for
 optimal utilization of the library.

- The effectiveness of planned curriculum implementation is reviewed by HODs in regular review meetings at departmental level.
- IQAC conducts meeting on course completion in every semester.
- Internal academic audit is conducted and any discrepancies identified are communicated to the teacher for improvement.

Performance evaluation of students

- Effectiveness of curriculum delivery is measured through students' performance in internal test like class test, Unit test and common test, seminar presentations, group discussions, laboratory experiment and University examinations.

2.3 Teaching- Learning Process

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences and teachers use ICT- enabled tools including online resources for effective teaching and learning process

Response:

The teachers of our institution facilitate learning by allowing each individual student to comprehend at their personal level by ensuring their involvement in class activities so that they can absorb and grasp information at their own pace. To enhance their learning experiences, apart from conventional chalk-talk method, teachers use other student centric methods discussed below.

- 1. **Experiential learning:** 'Learning by doing' is the most effective method of learning.
- Laboratory method is used in science subjects to acquaint the students with the facts through direct experience individually. Students verify the facts and laws of the subject with the help of experiments.

- Departments organize field visits, industrial visits, visit to scientific and educational places for students to provide exposure to the factual things and to develop scientific approach and understanding.
- Projects are one of the important components of the internal assessment which helps students acquire experiential learning.
- Students explore their talent by creating innovative scientific projects for inter-university research project competition 'AVISHKAR'.
- Students prepare Herbarium for instant referrals in taxonomical studies.
- Biological models are prepared by the students to study structure and function of different cell organism.

1. Participative Learning:

Teachers conduct student's seminar, group discussion, peer teaching, and debate etc. to help them to learn different skills. Students are encouraged to participate in collegiate and intercollegiate competitions and other activities where they can use their specialized technical or management skills. Also, guest lecture of teachers expert in the particular area are arranged for students.

1. Problem Solving Methodologies:

Students are assigned mathematical problems, puzzle, conduct open book test, circuits for fault findings and correcting, charts for labeling, incomplete physical and chemical equations to complete, combining two or more concepts, etc. brain storming problem solving methodologies are used to enhance learning experiences of the students.

ICT enabled tools for effective teaching-learning process:

ICT tools empower both teachers and learners. They transform the teaching and learning processes from being highly teacher-dominated to becoming student-centric and this transformation results in increased learning gains for students.

Besides the chalk and talk method of teaching, the college makes intensive use of ICT tools such as LCD projectors, Wi-Fi connectivity, Power Point presentations developed by teachers, Video clippings, video demonstrations from online sources like You Tube, providing reading materials and lab manuals through emails and social networking like whatsApp. Teachers of chemistry department use software like *Chemdraw* for effective teaching. Physics department use virtual lab of Amrita University to explain laboratory experiments. Mathematics department use Equation editor in seminar script presentation and projects. Students and teachers access e-learning resources like e-journals, e-Books, articles, video lectures etc.

During COVID-19 Pandemic situations entire teaching-learning and evaluation process was done in an online mode. The institution used Google Suit applications like Google Meet, Google

Classroom, Google Forms, Google Doc and Google Drive etc. for teaching, sharing study materials, assigning and collecting all internal assessment related material, conducting college examinations like unit test, class test, common test and University examinations.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

Assessment of students' performance is an integral part of the teaching-learning process and it is regularly implemented by the concerning teachers of the college. As an affiliated college, the internal assessment norms laid down by the Sant Gadge Baba Amravati University, Amravati are strictly followed by all the departments. The students are made aware about the internal and external assessment mechanism in detail and mark system laid down by the university is displayed on the departmental notice board for students' information.

The internal evaluation of students done by the respective teachers are on the basis of class-test, project assignments, seminars, study-tours, industrial visits, visits to educational institutions and research organizations, field work, group discussions or any other innovative practice/activity decided by the department and performance in laboratory practicals. College Examination Committee conducts 'Common Test' for all courses as per university examination paper pattern. Internal and external assessment of the students is done per semester i.e. twice in a year. The departments conduct reexaminations for the students who are involved in co-curricular or extra-curricular activities or sports events during the internal assessment schedules.

To ensure transparency in the assessment process, internal assessment marks are displayed on the notice boards by the departments.

The College has mechanism to deal with the grievances related to it.

Internal Assessment:

Immediately, after the class test, unit test, the marking scheme is discussed with the students. The students can see evaluated answer sheets and faculty undertakes individual grievances if reported by the students. If any discrepancies are reported by the students, then they are resolved by the faculty and revised marks signed by HOD are displayed on the notice board for transparency.

Faculty evaluates assignments and projects based on the rubric which is also shared with the students. The students can see the evaluated assignments and projects to maintaining the transparency of the marks assigned and to resolve grievances if any.

Lab experiments:

The experiments performed in lab by the student are evaluated by the faculty based on the lab rubric designed by the faculty. Grievances reported are immediately resolved.

Online Assessment:

During COVID-19 Pandemic situation all examinations and submissions are taken in Google classroom using Google forms. The students can directly see the marks and the correct answers immediately after examinations are submitted. They were advised to post grievances on the Google classroom or on WhatsApp. Grievances reported are resolved within a week.

External examinations (examinations conducted by the University):

As far as the grievances related to the external examinations *are* concerned, there is a separate mechanism of grievance redressal laid down by the university. Students having grievances in a particular subject are guided by the concern departmental teachers the redressal mechanism of the university.

Quality education is prime concern of the institution. Outcome-based education is the only measure of quality education. The college offers only B.Sc. programme with clearly stated and well defined Programme Outcomes (POs) and Course Outcomes (Cos).

- Graduate attributes are described to the first year students at the commencement of the programme through Induction program.
- Programme and course outcomes are discussed in departmental meetings.
- At least two initial periods are spent by the teachers for introducing the subject to the Students.
- Course outcomes are communicated during curriculum delivery.
- Learning outcomes of the Programs and Courses are observed and measured periodically by the teachers.
- Soft Copy of POs, PSOs and COs are uploaded on the Institution website for reference.
- The students are also communicated about the Course outcomes during syllabus delivery.
- Along with POs, PSOs and Cos, college includes crosscutting issues for environmental and Societal Consciousness, Ethics and Human values.
- From the current session 2022-23 the affiliating University introduced a CBCS system to widen the teaching and learning activities and to strengthen the outcome based education. In CBCS, students have compulsion to opt a skill based course along with regular course to reinforce the desirable outcome. 3.4 Extension Activities
